



## CITY OF MONTEBELLO PUBLIC HEARING NOTICE

**NOTICE IS HEREBY GIVEN** that the City Council of the City of Montebello will hold a Public Hearing in the Council Chamber of the Montebello City Hall, 1600 West Beverly Boulevard, Montebello, California, on **Wednesday June 23, 2021, at 6:30 p.m.**, or as soon as possible thereafter as the matter can be heard, to consider the following:

A revised and updated City residential refuse collection and curbside recycling program collection rate (collectively the "Rate"). The City will consider the adjustment of the Rate as follows as requested by franchisee and authorized by the Residential Waste Collection Agreement:

- Beginning on July 1, 2021, the monthly Rate for services provided under Agreement 668 between the City and AEI shall be \$28.07 per residential customer.
- Beginning on July 1, 2022 and on July 1 of each subsequent year until the Termination Date of Agreement 668, the Rate for services shall be adjusted in accordance with the then-latest available Consumer Price Index, as more specifically permitted pursuant to the formula set forth in Section 19 of Agreement 668, as amended.

All interested persons have the right to appear and be heard pursuant to Governor Newsom's Executive Orders N-25-20 and N-29-20. For those interested in making public comments, the City will receive your comments by contacting the City Clerk's office **on or before Wednesday June 23, 2021 between 9:00 a.m. – 3:30 p.m. at (323) 887-1359**. Staff will complete public comment cards in the order received. The public will be called during the City Council meeting that begins at 6:30 p.m. Closed Session begins at 5:30 p.m. The exact call back time is not predictable due to the nature of the City Council agenda. As a result, you must be available until the end of the meeting to receive a live call from staff during the meeting. The City has created an email address [ccpubliccomment@cityofmontebello.com](mailto:ccpubliccomment@cityofmontebello.com) where the public can submit public comments from **9:00 a.m. – 3:30 p.m. on Wednesday, June 23, 2021**. These questions will be read out loud and submitted for the record. If you challenge the rate adjustment in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City Council, at, or prior to, the public hearing.
